2. Absentee Bids are accepted with pre-approved credit card information. We reserve the right to open absentee bids at 80% of the bid price. We assume no responsibility for failure to execute these absentee bids. A 15% buyer premium will apply as well as shipping fees.
3. The Buyer assumes 100% responsibility of articles at the time of purchase. All risk of damage or loss is borne by the purchaser at the time the Auctioneer says "SOLD".
