You will also be required to sign the Property Purchase and Sale Agreement and to tender an additional Deposit towards the Purchase Price as listed in that Agreement. The additional Deposit must be paid in certified funds by the end of the next business day following the date of the auction. Once the Bidder Registration Fee check is endorsed to the Escrow Agent it is NON-REFUNDABLE for any reason other than if the Seller defaults by refusing to executed the Deed and other necessary documents to convey the Property. By signing below, you indicate your acceptance of these terms and conditions and you specifically acknowledge and agree that in the event that you do not close on the purchase of the Property for any reason other than the aforesaid type of default by the Seller, that the Escrow Agent is specifically authorized to disburse the Bidder Registration Fee to the Seller and Auctioneer, in accordance with any agreement governing such a disbursement that has been executed between Seller and Auctioneer.
