**TERMS & CONDITIONS OF CONSIGNMENT**

**All consignors will be held to Terms & Conditions of Consignment whether or not you read &/or sign the contract.  
 Grade horses will be accepted only for the Ranch Gelding Session & must work cattle.**

**Consignment fee MUST be paid in advance on All grade horses.**

**We do not accept horses on registration applications or pending registrations.**

1. The sale will be held on **March 12,13, 2010** at the George H. Henderson, Jr. Exposition Center, Lufkin, Texas.
2. A non-refundable consignment fee may be withheld from proceeds on registered horses only. An 8% sale commission will be withheld if sold.
3. Each nomination **MUST** be accompanied by a completed consignment form, the Original Certificate of registration, together with a properly signed transfer, and any breeders certificates or the contract will be void. No horse will be accepted for any session until all required paperwork has been received. **ALL HORSES MUST BE PROPERLY REGISTERED WITH THE PROPER ASSOCIATION. HORSES WILL NOT BE ACCEPTED ON APPLICATION OR PENDING REGISTRATION.**
4. Sale order and session will be as Sale Management desired, this is done by computer draw.
5. Sale Management reserves the right to reject at sale time any horse that in the sole judgment of management is not up to quality of the sale due to poor condition, sickness, injury or drugging. The nomination fee in such case shall not be refunded. All horses entered shall be subject to test by a licensed veterinarian for medication and drugs. Further, a buyer, at his expense, may cause a veterinarian's examination prior to sale, including pregnancy or fertility examination. It is anticipated by Sale Management that once a horse is accepted for sale that the said horse will be offered for sale on sale day. In the event consignor should elect to consummate a sale subsequent to consignment but prior to sale date, Sale Management must be notified immediately and a 10% commission will be paid to Management by consignor, plus the nomination fee. Any horse withdrawn from the sale is subject to a withdrawal fee of \$250 (in addition to the consignment fee set forth above).
6. If a horse is withdrawn from the sale due to sickness or injury, a letter from the veterinarian used must be furnished to the sale management and the withdrawal fee shall be waived. (The consignment fee is non-refundable).
7. Each horse is required to be Coggins tested negative in accordance with the regulations of the State of Texas Animal Health Control & an original written laboratory report thereof be furnished to Sale Management subsequent to the sale. Without a coggins we are not allowed by Texas State Law to unload horse(s). **ALL OUT OF STATE HORSES MUST HAVE HEALTH PAPERS IN ADDITION TO COGGINS.**
8. Each Owner covenants and warrants that the title of each entry is free of any and all liens and encumbrances and will warrant the title to the same.

9. All photos submitted with consignments for publication are at the risk and liability of the consignor. Sale Company shall not be liable for any copyright infringements.
  10. Any blemish, scar, swelling, cut or other irregularity of any kind must be furnished to Sale Management and the right to announce such findings at the time of sale is hereby granted. Violation of this clause or failure to announce may give the prospective buyer the right to return any horse to the consignor and the consignor must still pay the commission fee. If your horse is turned down for any of the above reasons the horse still belongs to you. Remember, if Sale Company does not receive payment (stop payment, turn down, etc), we cannot issue payment to you. It will also be your responsibility to make any arrangements with the prospective buyer on location and the pick up of any horse(s) should that occur.
  11. Sale Management does not act as an agent for or represent either the buyer or seller but merely provides an environment for binding together buyer and seller for the purpose of sale transactions.
  12. Sale Management and its agent shall not be responsible for loss or damage to horses, equipment, or persons from injury, accident, fire, theft, etc., in any manner, before, during, or after sale. **\*WARNING - UNDER TEXAS LAW (CHAPTER 87, CIVIL PRACTICE AND REMEDIES CODE), AN EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES.**

  14. Cattle fee will be \$35 for either roping or cutting or \$50 for both roping & cutting.
