NO LATE REGISTRATION WILL BE ACCEPTED. Commissions will be paid only after closing and after Broker has been paid in full. Brokers are not required to attend the closing. If a cooperating broker has not met all of these requirements, no commission will be paid to the cooperating broker, even if the cooperating broker's prospect purchases the Yacht.

No oral registrations will be accepted. Under no circumstances whatsoever will any commission be paid if the sale does not close.
